1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, Guam functions and succeeds as a result of the hard work of all
4 our working class heroes that serve our island everyday as workers, as parents, as
5 children, as friends, and as active citizens in our democracy; and

6 **WHEREAS**, Guam's working class heroes have long been the forgotten
7 backbone of our island, and they should be recognized for their commitment and
8 loyalty in serving the community; and

9 **WHEREAS**, there would be no tourism industry without hotel workers, no
10 schools without education professionals, no healthcare without nurses, no stores
11 without clerks, no phones without lines people, no clean streets without solid waste
12 professionals, no safe beaches and pools without lifeguards and park rangers, no
13 safety and protection without police officers and firefighters, no restaurants without
14 servers or cooks, no balanced books without accountants, no clean water without
15 water workers, no clean and maintained schools and buildings without custodians and

1 maintenance workers, and no children at school without bus drivers. Guam thrives
2 thanks to our working class heroes; and

3 **WHEREAS**, Mr. Raymond Guerrero has served over ten (10) years in the
4 Private sector inclusive of Military civilian work, contributing valuable knowledge
5 and skills in Guam’s working economy; and

6 **WHEREAS**, Mr. Raymond Guerrero worked for No Ka Oi as a Sentricon
7 Specialist III serving the company for about five (5) years. Mr. Raymond Guerrero
8 also worked as a subcontractor for the Navy as a Material Handler and for the Air
9 force as a Demil Technician for three (3) years handling explosives and heavy
10 equipment. Mr. Raymond Guerrero is one of the few citizens on island to hold a
11 Marine Radio Operator license; and

12 **WHEREAS**, Mr. Raymond Guerrero is currently a lineman for GTA
13 Teleguam, one of Guam’s communications providers, for over two (2) years. Mr.
14 Raymond Guerrero has shown interest in growth within the company by taking the
15 company’s “Learn and Earn” program and further expanding his skills through an
16 apprenticeship program at the Guam Community College for a Journeyman Certificate
17 in the Lineman Installation and Repair field which will be completed in about three
18 (3) years; and

19 **WHEREAS**, Mr. Raymond Guerrero has dedicated about fifteen (15) years
20 sporadically coaching the Guam Little League Baseball, Guam Babe Ruth League, as
21 well as the Adult Baseball League. Mr. Raymond Guerrero had the privilege of taking
22 the Guam All-Star teams for tournaments in Tinian for the World Series Tournament
23 and the Babe Ruth Regional Tournament in the United States;

24 **WHEREAS**, Mr. Raymond Guerrero actively participated in the American
25 Cancer Society’s Relay for Life event as Team Captain for Na Ko Oi in 2002, 2003,
26 2004 and 2006 and has committed his spare time as a Municipal Planning Council

1 Member for the Asan/Maina community discussing issues and concerns within the
2 village and; now, therefore, be it

3 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na Liheslaturan*
4 *Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people of Guam,
5 recognize Raymond Guerrero, one of Guam's working class heroes, for his hard work
6 and dedication, not just to his job, but to all the people of Guam; and does extend *Un*
7 *Dångkolo Na Si Yu'os ma'åse'* to Mr. Guerrero for his leadership and
8 accomplishments; and be it further
